**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF SUNNYSIDE, WASHINGTON, ACCEPTING
BID AND AUTHORIZING PURCHASE OF
SWAT TACTICAL VESTS
(Law Enforcement Equipment Distribution)**

WHEREAS, the City of Sunnyside has solicited sealed bids for SWAT Tactical Vests; and

WHEREAS, the City received two responsive bids and the lowest bid in the amount of \$22,930.04, including applicable taxes, was submitted by Law Enforcement Equipment Distribution; and

WHEREAS, the City Council finds and determines that acceptance of such bid is in the best interests of residents of the City of Sunnyside and will promote the general health, safety and welfare.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON, as follows:

Section 1. That the bid in the amount of \$22,930.04 submitted by Law Enforcement Equipment Distribution for SWAT tactical vests, is hereby accepted; and the City Manager is authorized to purchase said equipment as described in Exhibit "A", attached hereto.
