**A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF SUNNYSIDE, WASHINGTON, APPROVING  
2010 INTERLOCAL CORRECTION/DETENTION  
AGREEMENT WITH YAKIMA COUNTY**

**WHEREAS**, the City of Sunnyside has previously entered into Interlocal Correction/Detention Agreements with Yakima County regarding incarceration of prisoners within the facilities of each entity; and

**WHEREAS**, the City of Sunnyside and Yakima County are empowered to enter into such agreements pursuant to the provisions of Chapters 39.34 and 70.48 RCW; and

**WHEREAS**, the parties have negotiated an Interlocal Correction/Detention Agreement for the year 2010; and

**WHEREAS**, the City Council finds and determines that approval of such agreement is in the best interests of residents of the City of Sunnyside and will promote the general health, safety and welfare.


**NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON**, as follows:

**SECTION 1.** That the "2010 Interlocal Correction/Detention Agreement – Addendum I," a copy of which is attached hereto as Exhibit "A" and incorporated herein by this reference, by and between the City of Sunnyside and Yakima County, is hereby approved for the term January 1, 2010 through December 31, 2010.

**SECTION 2.** The City Manager is hereby authorized to execute and administer such agreement for and on behalf of the City of Sunnyside.

**SECTION 3.** This Resolution shall be effective upon passage, approval and signatures hereon in accordance with law.



Addendum I

THIS ADDENDUM TO THE 2010 INTERLOCAL CORRECTIONS/DETENTION AGREEMENT (hereinafter "Agreement") is made and entered into by and between **Yakima County** (hereinafter "County") and the **City of Sunnyside** (hereinafter the "City")

WHEREAS, the County and City already have an Agreement for jail services, expiring on December 31, 2010.

WHEREAS, the City desires to modify this Agreement.

NOW ,THEREFORE, in consideration of the mutual covenants, conditions, and promises contained herein, the parties hereto mutually agree as follows:

1. **Purpose.** To facilitate the effective daily operation of its jail, the City desires to house inmates from the County who are eligible and able to serve their jail sentence as trustee workers in Sunnyside.
2. **Selection.** The County will provide to the City a list of inmate candidates. The City will select those inmates it finds suitable. Inmates terminated from the City trustee program will be returned to the County.
3. **Daily Rate of Incarceration.** The City will not bill the County a daily rate for those inmates selected as trustees and housed by the City.
4. **Medical.** The City will provide industrial insurance coverage for all trustees assigned to inmate work crews, The City will provide medical care to these inmates for any injury that occurs while housed in Sunnyside. Should the City determine the inmate has a non-injury medical condition the City reserves the right to return that inmate to Yakima County.

The remainder of the Agreement remains unchanged.
